How To Do Business With The State Of North Dakota

Why Become Part of the State Bidders List?

Executive branch agencies and higher education institutions use the State Bidders List when issuing solicitations for goods and services.

The Process is Quick and Easy

Simply apply to be placed on the state bidders list to receive emails about new bid opportunities.

Is your business interested in bidding on state contracts? You can easily apply to be placed on the state bidders list, and receive notice of state bidding opportunities.

Effective August 1, 2023, Bidders List laws were changed to remove Secretary of State registration requirements.

BIDDERS LIST REGISTRATION

The bidders list is used by state executive branch agencies and institutions when issuing solicitations for goods and services \$50,000 and over. Go to www.omb.nd.gov/doing-business-state/procurement/registration-and-maintenance-bidders for bidders list registration information. It is recommended that you use a general company email address for instances when employees are absent or leave the company.

Choose commodity codes for the goods and services you sell. Commodity codes determine which bid notices you will receive. For a list of commodity codes, go to www.omb.nd.gov/doing-business-state/procurement/bidders-list-registration-and-maintenance and click on Commodity Codes.

SECRETARY OF STATE REGISTRATION

State law requires vendors that have a registration requirement with the Office of the Secretary of State must be registered before the contract award and the registration must remain active for the duration of the contract period (N.D.C.C. 54-44.4-09.1).
